

Privacy statement Quik companies

("Quik companies" refers to all companies within the Quik group, namely Quik's Verse Aardappelen B.V., Quik's Research & Development B.V., Quik's Potato Products B.V., Quik's Logistics B.V. and any other Quik companies)

General

Your privacy is of great importance to the Quik companies ("Quik"). It is important to us that you know how Quik handles your personal data. In this privacy statement, we therefore inform you about, among other things, how Quik processes personal data; for what purposes Quik processes personal data; and how you can exercise your privacy rights. We therefore advise you to read this statement carefully.

Application

This privacy statement applies to all visitors to Quik's website (www.quiks.nl) and to everyone else whose personal data is processed by Quik (with the exception of Quik employees, to whom separate documents apply). Quik is responsible for processing the personal data collected (including through the website with domain name www.quiks.nl).

Personal data processed by Quik

Quik processes your personal data when you use our website and/or when you provide it to us yourself. Which personal data we process depends of course on the contact between us. Below we have specified for you which personal data will be processed in which situation.

When you visit our website

- Data about your activities on our website (namely: the IP address, the identifiers in cookies, the internet browser and the device type)
- The personal data you actively provide via our contact form (i.e.: company name, name, address, postal code, city, country, email, telephone and message)

In case of a job application

- First and last name, any company details, gender, date of birth, place of birth, address, telephone number, email address, position, CV, cover letter and IBAN.
- Other personal data that you actively provide (e.g. by providing other information in the context of your application)

When visiting our company or making a phone call

- The personal data you actively provide to us.

Special personal data that Quik processes

Quik does not process special personal data, such as data relating to race, religion or health, unless these are provided to Quik by an applicant.

Quik does not intend to collect data about website visitors who are younger than 16 years of age, unless they have permission from their parents or guardian. However, we cannot check whether a

visitor is over 16 years old. We therefore recommend parent involvement in their children's online activities in order to prevent data from being collected about children without parental consent. If you have reason to believe that Quik has collected personal information about a minor without such consent, please contact us. We will then delete this data.

For what purpose and on what basis do we process personal data

Quik processes your personal data for the following purposes:

- With regard to personal data via the website: User-friendliness, functionality, visit analysis for marketing.
- With regard to personal data via the contact form on the website: Answering your question and/or providing the trial package you requested and/or making an appointment at your request.
- With regard to personal data via the job application: the job application procedure.
- With regard to personal data provided by other means: for product delivery or for marketing and business development purposes.

We may only process your personal data if there is a legal basis for doing so. Processing takes place on the basis of the legal bases in the GDPR, i.e. for the performance of an agreement (e.g. a contract for the sale of our products), due to a legal obligation, with your consent and/or due to a legitimate interest.

How long we retain personal information

Quik does not retain your personal data for longer than is strictly necessary to achieve the purposes for which your data is collected. We apply the statutory retention periods.

When you visit our website

- Data about your activities on our website (namely: the IP address, the identifiers in cookies, the internet browser and the device type): no longer than necessary for the purpose for which we have collected and recorded them within any applicable legal retention obligations and/or periods.
- The personal data you actively provide via our contact form (i.e.: company name, name, address, postal code, city, country, email, telephone and message): no longer than necessary for the purpose for which we have collected them and recorded them within any applicable legal retention obligations and/or periods.

In case of a job application

- First and last name, company details, gender, date of birth, place of birth, address, telephone number, email address, position, CV, cover letter, IBAN and any other personal information that you actively provide (e.g. by providing other information in the context of your application): 4 weeks after the end of the application procedure (without consent) and 1 year after the end of the application procedure (with the consent of the applicant).

When visiting our company or during a phone call

- The personal data you actively provide to us via access control: 6 months after the right of access has expired.

- The personal data you actively provide to us for acquisition purposes: no longer than necessary for the purpose for which we have collected them and recorded them within any applicable legal retention obligations and/or periods.

Sharing of personal data with third parties

Quik will not provide your data to third parties and will only do so if this is necessary for the execution of our agreement with you or to comply with a legal obligation. To ensure the same level of security and confidentiality of your data, we enter into processing agreements with companies that process your data on our behalf. Quik remains responsible for these processing operations.

In special cases, Quik may make your personal data available to third parties, regardless of your consent. These may include requests from authorities, legal summons or court orders.

Cookies we use

A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone on your first visit to this website.

On our website, cookies are used to:

- enable functionalities of the website and to protect the website (technical or functional cookies);
- analyse the use of the website and improve the website on that basis (analytical cookies).

During your first visit to our website, we informed you about these cookies and requested your consent to place them.

You can unsubscribe from cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored through your browser's settings.

Accessing, correcting or deleting data

You have the right to access, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Quik, and you have the right to data portability. This means that you can submit a request to us to send the personal data that we have about you in a computer file to you or to another specified organisation.

You can send a request for access, correction, deletion, transfer of your personal data or for the withdrawal of your consent or an objection to the processing of your personal data to privacy@quiks.nl.

If you submit a request to us for access, correction, deletion or transfer of your personal data or a request to withdraw your consent or an objection to the processing of your personal data, we will ensure that your request is dealt with within one month. Depending on the complexity of your request and the number of requests, this period may be extended by two months. If we are unable to process your request within the period of one month, we will inform you of this in good time.

To verify that the request for access has been made by you, we ask you to send us a copy of your identity document with the request. In this copy, blacken your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN). This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.

How we protect personal data

Quik takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorised access, unwanted disclosure and unauthorised alteration. For example, we ensure that only the necessary Quik persons have access to your data and that security measures are regularly checked. If you have the impression that your data is not properly secured or there are indications of misuse, please contact us immediately.

Modification of privacy statement

Quik reserves the right to modify this privacy statement. You are therefore advised to read privacy statement on a regular basis to stay informed about how Quik processes your personal data.
